The Supreme Court case hinged on whether the disciplinary actions improperly denied students their rights to a public education. In ruling for the students, the Court granted "rudimentary" due process rights to those suspended from school for fewer than 10 days, as well as "more formal protections" for students facing longer exclusions.
